### **RETURNS FOR CREDIT POLICY**

A Return Authorisation (RA) is required prior to returning a part for credit or replacement.

This is acquired by phoning Dasko, who will email or fax you the paperwork, which must be completed and returned with the item. This process enables us to issue credits without delay.

Products not returned in resalable condition will incur a 10% repackaging fee.

Products returned outside the company policy time of 14 days after invoice date will incur a 10% handling and restocking fee.

Under no circumstances can goods be returned after 2 months from invoice date, without prior permission in writing from Dasko management.

All goods for return must have invoice number/s and date/s of purchase.

Procured items are non-returnable and non-refundable.

Electronic components are non-returnable and non-refundable once fitted.

Dasko is not responsible for the freight cost of returning products for credit.

### WARRANTY POLICY

Any item returned under warranty requires a Return Authorisation (RA) and a Warranty Claim form to be completed and returned with the faulty item. These are acquired by phoning Dasko prior to returning the item. This process enables us to evaluate and remedy your claim quickly.

It is at Dasko Marketing's discretion whether a warranty is fair. Dasko Marketing will decide whether to repair or replace.

Under no circumstance will Dasko Marketing be held responsible for other costs incurred due to product failure.

Dasko is not responsible for the freight cost of returning products for credit.

### **COMPLETE UNIT & COMPONENT WARRANTY**

Passenger vehicles (Petrol)	12 months or 20000 kms*
Passenger vehicles (Diesel)	12 months or 20000 kms*
Commercial vehicles, taxis	12 months or 20000 kms*
Industrial, agricultural, ATV	12 months or 500 hours*
Fork truck vehicles	6 months or 500 hours*
Marine	6 months or 500 hours* * Which ever occurs first.

Warranty is void if the Dasko serial number is removed.

Warranty is void if unit has signs of water, rust, diesel or oil internally, or external abuse or modification.

### **EXCEL AUTOMOTIVE PRODUCTS WARRANTY**

At Dasko Marketing's discretion, these carry a 12 month / 20000 km warranty against defects in manufactured materials and workmanship.

Where possible, all faulty items will be analysed and tested, and a written report supplied.

Dasko will not be held responsible for any outside costs incurred.
